#3. Pennsylvania Child Abuse History Clearance - www.compass.state.pa.us/CWIS - Church office will provide a special code for you to enter online to waive the fee.

- **Self Disclosure Form** - Volunteers who have been a continuous resident of Pennsylvania for the past 10 years do not need to obtain the FBI Criminal Background Check. Instead, complete the attached Self Disclosure Form return to your team leader.

Or

- **Federal Bureau of Investigations (FBI) Criminal Background Check** - Separate instructions will be emailed to you by the church office once you have completed #1-3. This must be completed for an new resident to the state of PA within the last 10 years.
